Gem State Adventist Academy ("GSAA") has a policy and practice of operating a "Closed Campus" for motor vehicles. This policy restricts students from driving a motor vehicle while enrolled at GSAA except for transportation to and from the campus each day for school and related purposes. It also restricts students from riding in other students' cars to a school sponsored activity. This is due to a high liability risk GSAA is not able to accept. It is strongly recommended that students ride in school transportation.
